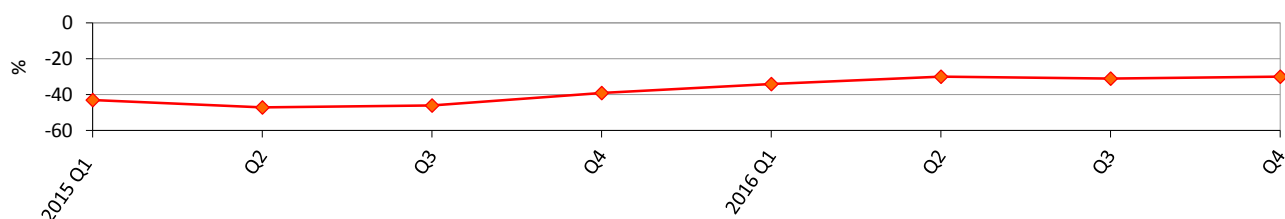
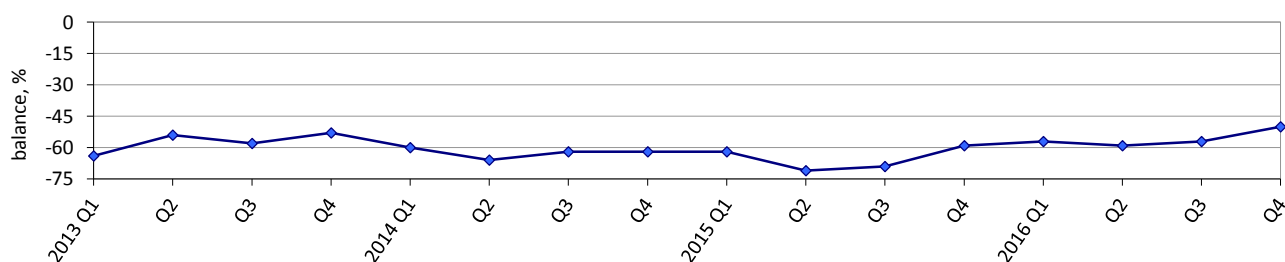

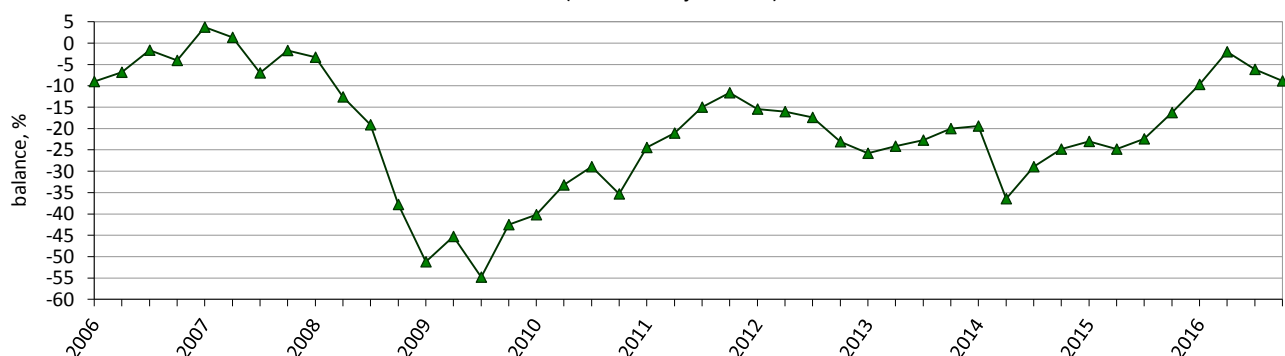
Construction confidence indicator²



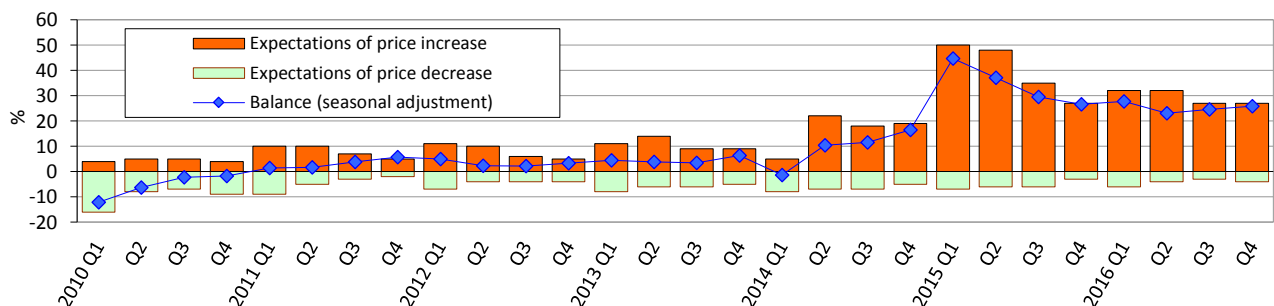
Assessment of the current order-books

(seasonal adjustment)**



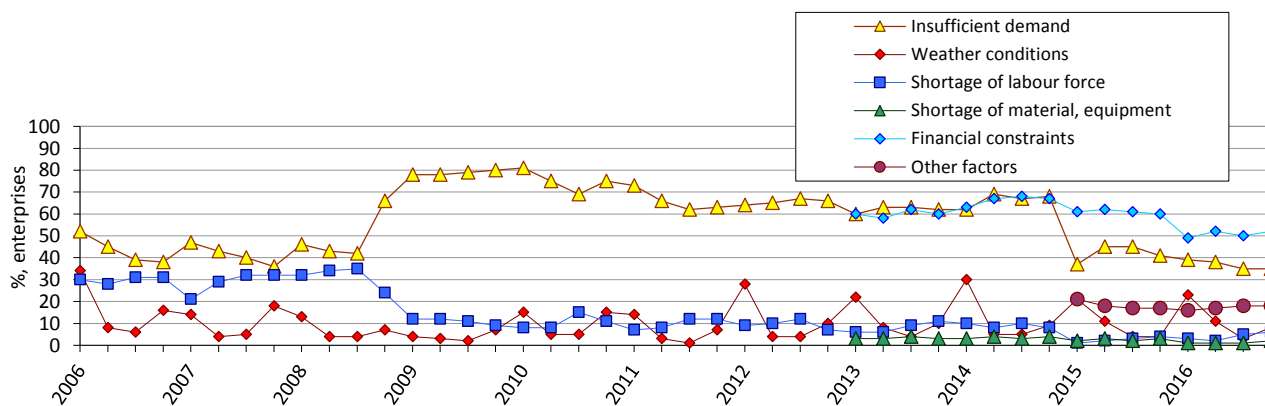
**Expected changes in prices of work performed
by construction enterprises**



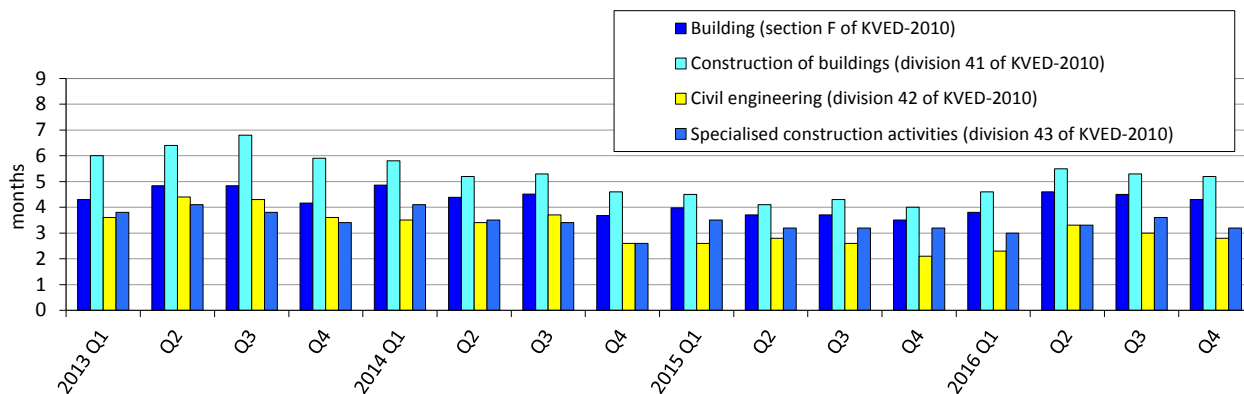
