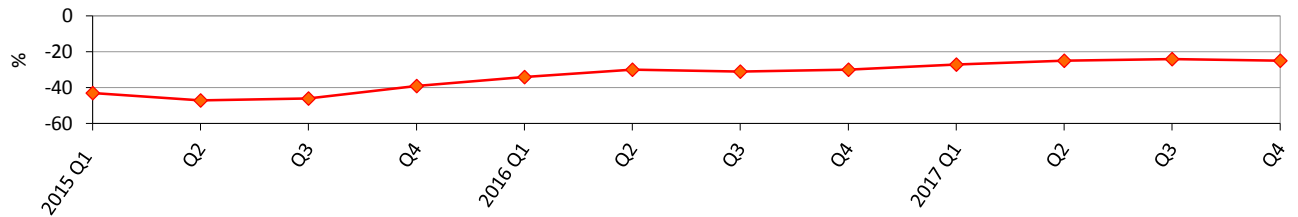
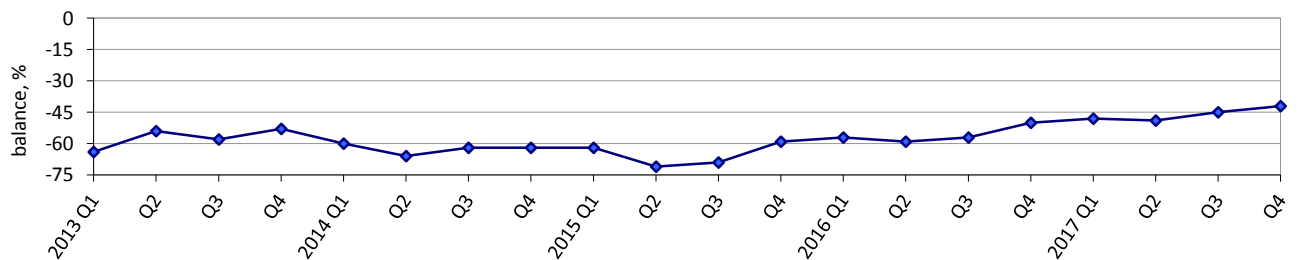

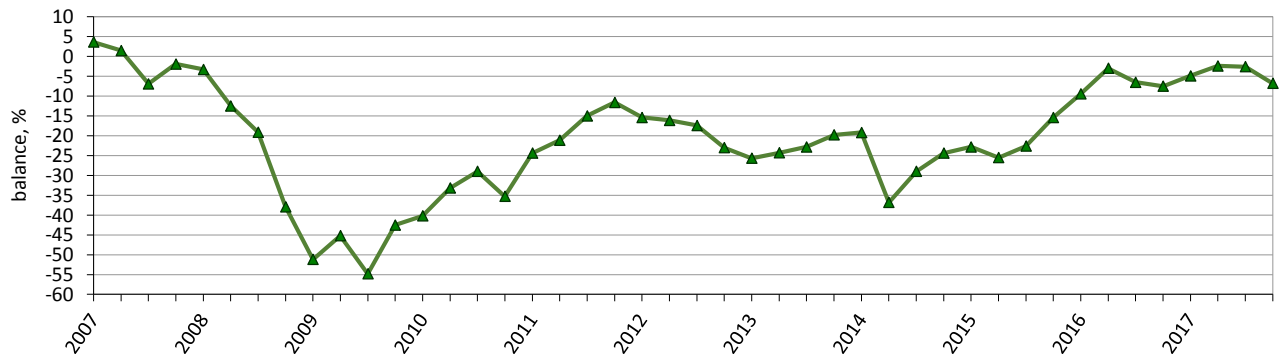
**Construction confidence indicator<sup>2</sup>**



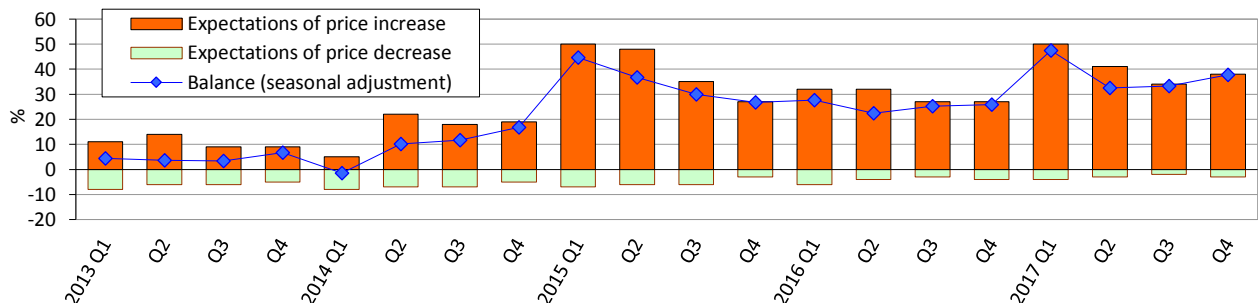
**Assessment of the current order-books**

by construction enterprises**

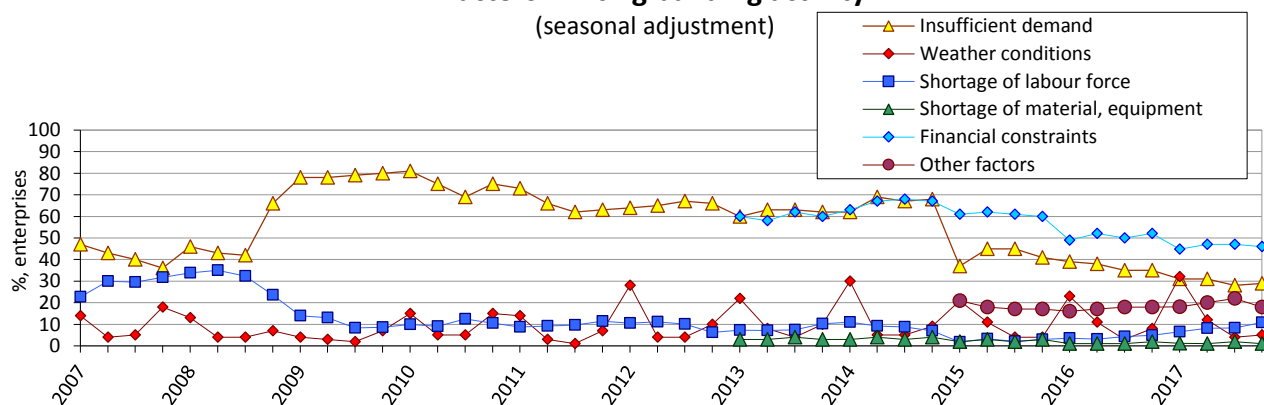

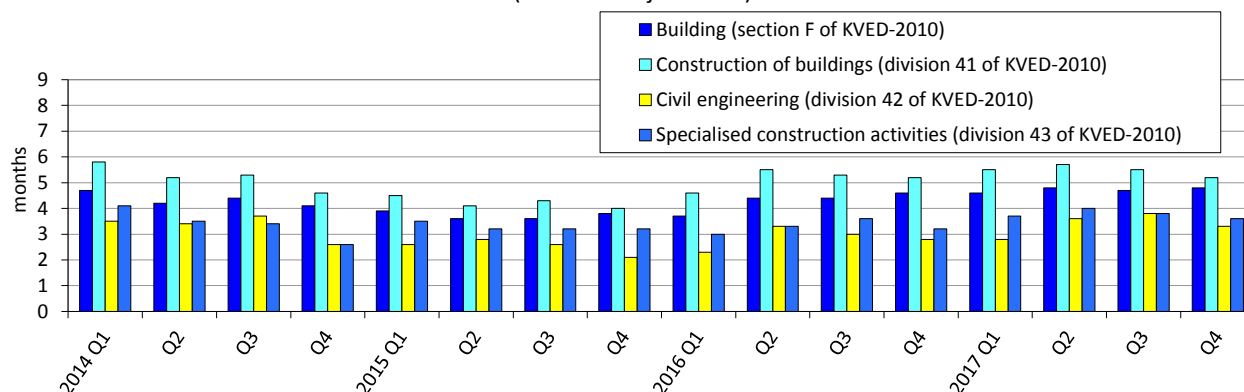
## Factors limiting building activity
