



**Industrial confidence indicator<sup>1</sup>**




**Business climate indicator<sup>1</sup>**

(seasonal adjustment)**














### Expected changes in selling prices




## Expected changes in employment at industrial enterprises (seasonal adjustment)




## Factors limitings production (seasonal adjustment )
